TERMS OF SERVICE POLICY

1. Acceptance of Terms of Service and Amendments

Each time you use or cause access to this web site, you agree to be bound by these Terms of Service, as amended from time to time with or without notice to you. In addition, if you are using a particular service on this web site or accessed via this web site, you will be subject to any rules or guidelines applicable to those services, and they will be incorporated by reference within these Terms of Service. Please read the site's **Privacy policy**, which is incorporated within these Terms of Service as Item 16.

This Terms of Service Statement applies only to the Web site at <http://300mclub.org/index.php> and the associated Bulletin Board Forum web site at <http://300mclub.org/forums/index.php>. These web sites are owned and operated by the New 300 Enthusiasts Club, Inc. (DBA Chrysler 300M Enthusiasts Club), and should not be confused with any other Web site whether or not the words Chrysler, 300, or 300M appear as part of the domain name or branding. You are advised to check each page you visit on or from this site to determine whether you have moved onto a third party site.

2. Forum Usage

Chrysler Enthusiasts 300M Club is a community established for individuals who own or simply appreciate the Chrysler 300M and all other LH platform automobiles. The Club forum is a diverse group with Members and Guests from all over the world. Considering this diversity, and to make the Club an enjoyable place for our members, we have adopted the following simple guidelines.

- Vulgar language, images, and other offensive materials including, but not limited to, pornography, racist content or other intolerant material are not permitted. The Board of Directors and moderators shall be the sole judges of what shall be considered appropriate content. Links to websites with offensive content are included in this rule. We strive to maintain a family-friendly atmosphere.
- Discussion and healthy debate are encouraged; however flaming and other intentionally antagonistic posts are not acceptable. Our Members are all to be treated as members of a community. Members are expected to behave as one would in mixed company. Name-calling, intentional abuse or otherwise creating a hostile environment for other Members is forbidden. Personal attacks on other Members are strictly prohibited. Any postings that reflect contempt of the 300M Enthusiasts Club will not be tolerated. Constructive, non-personal criticism, suggestions, and civil discourse are permissible; personal attacks on the Club, its Members, Guests or Board of Directors are not.
- This Club is financed by the annual membership fees paid by our Members. The Members-only areas are provided exclusively for those who financially support this Club. Please do not repost information from the Members-only area to the public forums. The Buy/Sell/Trade area is provided for paid Members to post ads. Non-paid Guests may respond to threads, but they may not otherwise post in this area. No solicitation posts are allowed in other areas of the forum.
- Each Member or Guest is allowed one login account. Registering with multiple accounts is not allowed and may result in the removal of all accounts without notice. Creating an account using a false real name or a non-working e-mail address are also grounds for account deletion or banning of the Member or Guest.
- Posting of, or linking to, copyrighted or illegal material is not permitted. Fair use guidelines allow for short segments of articles to be quoted, but please provide a link to the original source when possible and do not post entire articles without permission of the copyright owner.

- These guidelines cover most common situations, however the Board of Directors and Forum Moderators have the final say about what is acceptable and we reserve the right to take any actions we deem appropriate to maintain the spirit of the rules. If you have any questions or concerns, please address them privately to the Board of Directors, not in the open forum.
- "Flooding" is generally defined as bumping other threads out of view in order to increase your own visibility, or to decrease the visibility of another thread, and is not permitted. Flooding can take the form of cross-posting identical threads in different Message Boards, or multiple threads in any one Message Board with identical or nearly identical content. We reserve the right to move or delete any offending threads.
- An "**Internet troll**" or "**Forum Troll**" or "**Message Board Troll**" is a person who posts outrageous messages to bait people to answer. Forum Trolls sow discord on forums, inspires flaming rhetoric, is purposely provoking and pulling people into flaming discussion. Flaming discussions usually end with name calling and a flame war. This is not allowed on our site. Personal attacks are viewed independently of what prompts them, and anyone who attacks anyone else, regardless of whether or not that person is behaving like a troll, is subject to a warning or termination. Do not, under any circumstances, inflame the situation by replying to or attacking a troll.

Membership or participating as a Guest at this Club site or Club forum site is a privilege, not a right. As a private forum the Board of Directors has final say over what is acceptable. Generally the 1st offense will result in a warning, 2nd offense will result in a 10 day ban. Exceptions will be discussed by the BOD, in a timely manner, and their decision shall be binding.

Warnings and Bans will be issued by the current BOD forum name for the given year. The decision is a collective effort among all Directors and the results will be administered by the entire group as well to eliminate any accusations of favoritism.

3. Site Security

You are prohibited from violating, or attempting to violate, the security of this site. Any such violations may result in criminal and/or civil penalties against you. We will investigate any alleged or suspected violations and if a criminal violation is suspected, we will cooperate with law enforcement agencies in their investigations. Violations of the security of the site include without limitation:

- Logging into or attempting to log into a server or account that you are not authorized to access;
- Accessing data or taking any action to obtain data, information or services not intended for you or your use;
- Attempting to probe, scan or test the vulnerability of any system or network;

harassing, defamatory, threatening, vulgar, sexually explicit, hateful or otherwise objectionable language or material of any kind, any material that exploits children or is invasive of or in breach of another person's privacy or other rights or any material that Chrysler 300M Enthusiasts Club in its sole discretion does not wish posted or transmitted on the site.

- Defame, abuse, harass, stalk, threaten or otherwise violate the legal rights (such as rights of privacy and publicity) of others;
